Alexa led the creation of successful development agreements with 17 cities and five counties to secure entitlements for 17 master-planned communities spanning 25,000 acres. She built stakeholder relationships and gained trust and buy-in while managing initiatives leading to successful legislation at the state level to create municipal utility districts (MUD's) to enable subsequent development of the affected properties. Additionally, she led the company's participation in the Greater San Marcos Economic Development Partnership, a multi-community organization dedicated to economic development in Hays and Caldwell counties.

Prior to Walton Development, Alexa worked for several South Texas real estate development firms where she was engaged in projects of all sizes. She assisted with negotiating a long-term land lease and secured all necessary approvals for a 145-unit mixed-use facility with 38,000 square feet of ground floor retail space in downtown Austin. She also was a critical driver in work toward developing agreements for a proposed 1,900-acre master-planned community in Georgetown, Texas.

Alexa received her Master of Business Administration from Texas State University. She received her Bachelor of Science in Civil Engineering with a concentration in environmental studies from Lehigh University.
